C. Edwin Boyd, Jr. R.Ph.

Motion-Mr. Blackmon made a motion to issue a public reprimand with a \$1,000 fine, two year probation, to reinstate Mr. Boyd's license, and to take Board approved ethics course. Mr. Strauss seconded the motion, which carried unanimously.

Joseph J. Brownholtz, R.Ph.

Motion-Mr. Livingston made a motion to issue a public reprimand, reinstate Mr. Brownholtz's license, issue a \$500 fine and must enter into a five-year contract with RPP. Mr. Blackmon seconded to motion, which carried unanimously.

Zachary Brandon Ott, R.Ph.
