Z. NDDOP for Hospital Owned Clinics

This means the responsibility for the site would be under the permit under the hospital and action could also be taken against the director of pharmacy in the event of a problem. This does not prohibit a hospital from obtaining a non-dispensing drug outlet permit and obtaining a consultant pharmacist should they choose to do so.
