2025-2026 APPRAISAL MANAGEMENT COMPANY RENEWAL

- Check or money order only (no cash) in the amount of \$500 made payable to LLR-Real Estate Appraisers Board. (All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.)
- Registrations not renewed by June 30, 2025 will be expired. Performing real estate appraisal without a valid registration may result in disciplinary action. Expired registrations may be reinstated in accordance with S.C. Code Ann. §40-60-350.
- Include updated bond continuation certificate or <u>approved bond form</u>, for coverage to June 30, 2026. Board approved forms must be used and may be found here: https://www.llr.sc.gov/appr/pub.aspx
- Each owner (individual or entity) with an ownership interest in the appraisal management company must complete the applicable forms and submit to the Board with the Appraisal Management Company renewal application.
- Any changes in the entity's name, address, organizational status or federal identification must be reported to the Board prior to renewal. Failure to report these changes may result in a registration cancellation.
