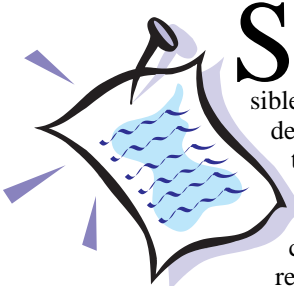

From the Administrator's Desk



Since January 1998, a coalition of people responsible for regulating design and construction in South Carolina has met to discuss coordinating requirements among

state agencies and to develop and implement strategies to assist those of you who work in South Carolina. Other topics have included the International Building Code, design/build, licensing and seal requirements, health care facilities in SC, and the impact of technological change on the professions.

The chief administrators of the Board of Architecture, Board of Engineering, Building Codes Council, and Contractors' Licensing Board participate as well as the State Fire Marshal, State Engineer, and directors of facilities management for the Department of Education and Department of Health and Environmental Control (DHEC).

One tangible outcome of the meetings has been the establishment of a link from the State of South Carolina's web page to all the agencies you may need to contact for information about designing a building or constructing a facility in this state. For example, if you are designing a health care facility, you will link to DHEC's web site; if you have questions about architectural plans,

you will link to this Board's web page; questions about engineering may be answered by accessing the Engineering Board's web site; if you need building code information, you will link to the Building Codes Council's web page.

We realize that dealing with governmental agencies—whether on the state, national, or local level—can be a frustrating and confusing experience. The web site link will offer assistance in dealing with the labyrinth of state regulations.

What else can we do to facilitate your design and construction work in South Carolina? We welcome your suggestions.

From the Chairman's Desk

I welcome this opportunity to share information with you as well as the Board's philosophy on certain current issues. Please feel free to send me your comments on these or any other topics.

1. "ROLLING WINDOW" FOR A.R.E. CANDIDATES

In 1989, the South Carolina legislature approved a statute requiring S.C. candidates to pass all divisions of the A.R.E. in four years or lose credits for the divisions already passed. Commonly referred to as the "rolling window," this requirement was timed to go into effect in June 1993, meaning the first loss of credits would be in December 1997 followed by another round in June 1998. Under this same statute, however, candidates are protected from losing eligibility to sit for the exam. Professional examinations such as the A.R.E. are designed to determine minimum competency. We believe there are sufficient changes in practice, technology, materials, and codes within a four-year period to warrant re-examination should a candidate not successfully pass in a timely fashion.

2. FIRE SPRINKLER SYSTEMS

Recently a letter was sent to all architects, engineers, contractors, and building officials registered in South Carolina regarding enforcement of a 1994 law concerning fire sprinkler systems. This Board was included in an effort to step up enforcement of the requirement that an engineer design and seal the plans for the sprinkler system and that the spec sheet be submitted with bid documents for new construction. As you can imagine, this change created a lot of confusion since it is contrary to traditional practices. The Board is recommending changes that, if approved, would allow the spec sheet to be submitted at a project's permitting stage, rather than at the bid stage. We will keep you abreast of developments in this area.

3. COMING UP

The Board has a unique opportunity in 1999 to participate in two significant meetings as Host State.

In February 1999, Deans and professors of the schools of architecture in ten southeastern states will convene at Clemson University for the annual Educators' Conference, co-hosted by this Board and the

Southern Conference of NCARB. Agenda topics will focus on how practitioners and the Conference can assist schools, and in particular, offer financial support. Harvey Gantt, former mayor of Charlotte, NC, and a

Disciplinary Actions

The Board conducted an Administrative Hearing on May 28, 1998, into the matter of **Donald F. Evans**, Registered Architect, Orlando, FL, and his firm's involvement in a condominium project in Myrtle Beach, SC. The Board found that Mr. Evans' firm, **The Evans Group, Inc.**, was not registered to practice architecture in South Carolina at the time the professional services for the project were provided. The Board also found that design documents for the project, which were offered for permit, were submitted with a false firm (corporate) seal containing a nine-digit number which purportedly was the South Carolina Certificate of Authorization number of the Evans Group, Inc. The Board found Mr. Evans guilty of misconduct and imposed a Public Reprimand, required registration of The Evans Group, Inc., and imposed a fine of \$4,500.00 plus costs of the investigation.

James M. Edwards, Registered Architect, Brentwood, TN, and his firm, **Edwards +Hotchkiss Architects, Inc.**, entered into a Consent Order with the Board for providing professional architectural services for 13 restaurant projects in South Carolina. At the time the services were provided, the firm was not registered to practice architecture in South Carolina. Sanctions imposed were a Public Reprimand and fine of \$3,250.00; the firm is now registered to practice architecture in South Carolina.

Solomon Peterson, Principal, Rock Hill, SC, entered into a Consent Order with the Board for providing architectural services in the name of his firm, **Solomon Peterson & Associates**, for a student housing project. At the time the services were provided, the firm was not registered to practice architecture in South Carolina. The Board imposed sanctions of a Public Reprimand and fine of \$3,000.00; the firm is now registered to practice architecture in South Carolina.

Harvey Jacoby, Registered Architect, Orlando, FL, and his firm, **Interplan Practice Limited**, entered into a Consent Order with the Board for providing professional services for 13 commercial projects in South Carolina. At the time the services were provided, the firm was not registered to practice architecture in South Carolina. Sanctions imposed were a Public Reprimand, \$2000.00 fine, and immediate firm registration.

Corporate Design Studio, Inc./Brooks/Burr, Inc., Atlanta, GA, entered into a Consent Order with the Board regarding services it provided for renovation of an office building in South Carolina. At the time the services were provided, the firm was not registered to practice architecture in South Carolina. Sanctions imposed were a Public Reprimand and \$500.00 fine; the firm is now registered to practice architecture in South Carolina.

Mark E. Humphreys, Registered Architect, Dallas, TX, entered into a Consent Order with the Board for providing professional services in the name of his firm, **Humphreys & Partners Architects**, for three apartment complexes in South Carolina. At the time the services were provided, the firm was not registered to practice architecture in South Carolina. Sanctions imposed were a Public Reprimand, \$500.00 fine, and immediate firm registration.

Thomas A. Popa, Registered Architect, Cedar Rapids, IA, entered into a Consent Order with the Board for providing professional services in the name of his firm, **OPN Architects, Inc.**, on a commercial project in South Carolina. At the time the services were provided, the firm was not registered to practice architecture in South Carolina. The Board imposed sanctions of a Public Reprimand, \$500.00 fine, and immediate firm registration.

Mitchell C. Smith, Registered Architect, Seattle, WA, entered into a Consent Order with the Board for providing professional architectural services in the name of his firm, **Mulvanny Partnership Architects**, for a commercial renovation project in South Carolina. At the time the services were provided, the firm was not registered to practice architecture in South Carolina. Sanctions imposed were a Public Reprimand, \$500.00 fine, and immediate firm registration.

E. Clay Elder, Registered Architect, Charlotte, NC, entered into a Consent Order with the Board for providing professional architectural services in the name of his firm, **ESD**, for two commercial projects in South Carolina. At the time the services were provided, the firm was not registered to practice architecture in South Carolina. The Board imposed sanctions of a Public Reprimand, \$500.00 fine, and immediate firm registration.

Gerald H. McCartha, Registered Architect, Charlotte, NC, entered into a Consent Order with the Board for providing professional architectural services in the name of his firm, **McCartha Architecture**, for five pharmacies in South Carolina. Sanctions imposed were a Public Reprimand and \$500.00 fine; the firm is now registered to practice architecture in South Carolina.

Management of Architectural Construction, Inc., Charleston, SC, was issued a Cease and Desist Order for representing itself in advertising and other documents using a name or title tending to convey the impression that the company offered to practice architecture. The company, which is not registered to practice architecture in South Carolina, subsequently changed its name to **Russ Cooper Associates, Inc.**

NCARB Adopts New Rules for Addressing Falsified IDP Documentation

Based on a recommendation from the Professional Conduct Committee, the NCARB Board of Directors recently approved procedural rules for cases where interns submit falsified Intern Development Program (IDP) training information. Under the new rules, NCARB will disallow IDP training units for the period covered by a falsified employment verification/IDP training unit report form. In addition, no training units may be earned for a period of one year beyond the reporting date, and the Council Record will not be transmitted to a registration board during that time. At the end of the one-year period, the Professional Conduct Committee must review the incident before reactivating the intern's record.

According to Robert Rosenfeld, NCARB Director of Student and Intern Services, incidents of forged or altered documents are relatively rare. "The vast majority of interns and employers are scrupulously honest in their reporting of IDP activity," Rosenfeld said. "The new rules have been adopted to maintain the integrity of our reporting system. NCARB staff carefully reviews every report and have been trained to identify any inconsistencies."

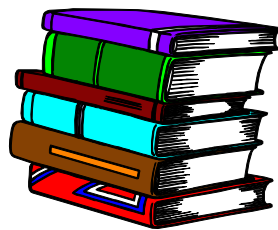
The National Council of Architectural Registration Boards (NCARB) has added the practice software for the Architect Registration Examination (ARE) to its web site. Exam candidates can now download the software directly into their computers by signing on to the site at <http://www.ncarb.org> and following the links to the examination information.



The software includes tutorials to teach candidates how to use the various testing tools found in the three graphic divisions of the ARE. There are no practice programs for the six multiple-choice divisions. Following the tutorials are 15 representative vignettes, one for each of the 15 vignettes that make up the graphic divisions.

Previously, candidates had to request the ARE software after they were made eligible by their state registration boards or provincial architectural associations. Now the software is being sent to all candidates on diskette, but with the addition of an online version, architectural interns can begin to familiarize themselves with the ARE software even before they become eligible candidates.

Usry Elected Chairman of the Southern Conference of NCARB

Since 1981, Batson Architects Inc., has specialized in the design of health care facilities. Projects include the St. Francis Women's Hospital in Greenville; Carolinas Medical Center Surgery Tower in Charlotte, N.C.; and the Oconee Memorial Hospital's Outpatient Facility Addition.
