# 2025-2027 MOBILE BARBERSHOP RENEWAL APPLICATION

### **Renewal Instructions / Requirements:**

- Check or money order (DO NOT MAIL CASH) in the amount of \$125 made payable to LLR Board of Barber Examiners.
- Renewal form, appropriate fee and any other applicable documentation are due by June 30, 2025. All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.
- Renewal must be postmarked by June 30, 2025, or it is considered lapsed and practice is not allowed. Applications postmarked July 1, 2025, or after must include the renewal fee + \$25 reinstatement fee for each license.
- License will not be renewed until the manager on record has renewed his/her license AND the shop has passed inspection.
