## Fundamental of Engineering (FE) and Fundamentals of Surveying (FS) Exams

The Fundamentals of Engineering (FE) and Fundamentals of Surveying (FS) exams are offered year-round as computer-based exams at approved Pearson VUE testing centers located in major cities throughout the country. For additional information visit www.ncees.org

There is **NO** application required to take the FE and FS exams. **Candidates should register DIRECTLY with NCEES** by visiting the NCEES website, <a href="www.ncees.org">www.ncees.org</a>. Candidates will select an exam date, location, and designate "South Carolina" as the examination State board when registering with NCEES. The exam fee will be paid to NCEES via major credit card at the time of registration.

Once you have passed the exam, you may apply for certification as an EIT or LSIT by filing the appropriate application with the Board, <a href="https://llr.sc.gov/eng/pub.aspx">https://llr.sc.gov/eng/pub.aspx</a>

# <u>Principles and Practice of Engineering (PE), Principles and Practice of Surveying</u> (PS) and State Specific Exams

NCEES has now transitioned all exams to a computer-based format, with the exception of the PE Structural exam. All CBT exams are offered at approved Pearson VUE test centers. Some PE exam disciplines are administered year-round, and others are administered on a single day each year. Contact NCEES for more information.

PE exam candidates must apply with the SC Board for approval to take the PE exam, **before** registering with NCEES. Applications for the PE exam are available online at <a href="https://llr.sc.gov/eng/pe.aspx">https://llr.sc.gov/eng/pe.aspx</a> (scroll down to the appropriate exam application and download **ALL** forms under that heading) and should be submitted to the Board office.

The Principles and Practice of Surveying (PS) exam transitioned to computer-based testing (CBT) effective October 1, 2016. The new PS exam will allow for year-round testing at approved Pearson VUE test centers. PS exam candidates must apply with the SC Board for approval to take the PS exam, **before** registering with NCEES. Applications for the PS exam are available online at <a href="https://llr.sc.gov/eng/pub.aspx">https://llr.sc.gov/eng/pub.aspx</a> (scroll down to the appropriate exam application and download **ALL** forms under that heading) and should be submitted to the Board office.

The SC State Specific Surveying (SS) exam is available in a computer-based format and is offered twice a year at PSI Testing Centers. The exam is offered the first Friday in May and November. Candidates must apply with the Board for approval to take the State-Specific Surveying exam. **Application Deadlines for State-Specific Exams:** 

February 1 (for May exam) and August 1 (for November exam).
