Further, I understand that as an “emeritus” professional I may reactivate my license only in the manner prescribed for a registrant whose license has expired because of non-payment of renewal fees, and then only after completing continuing education requirements for each exempted biennial renewal period not to exceed two renewal periods and shall submit applicable fees.
