- Biennial renewal fee of \$300 in the form of a check or money order only (no cash) made payable to Board of Registration for Geologists. (All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.)
- Biennial Renewal / Late Fees:

Renewed/postmarked on or before 6/30/2023: \$300 Renewed/postmarked 7/1/2023 - 12/31/2023: Late Fee \$150 + Renewal Fee \$300 = \$450 After December 31, 2023, your license is lapsed and must be reinstated.

- Renewals submitted after June 30, 2023, will require proof of CE.
