Requirements of Closure of a CRCF

It has come to the Division of Health Licensing's attention that some administrators have not realized they are responsible for taking certain steps when a community residential care facility plans to close. Prior to closing, the facility administrator, in accordance with the requirements of R. 61-84, <u>Standards for Licensing Community Residential Care Facilities</u>, must:

- Give residents a 30-day written notice of the closure date of the facility.
- Contact placement agencies and sponsors to arrange for the appropriate relocation of the residents.
- 3. Provide residents with a refund of monies, as appropriate.
- 4. Provide residents with their medications, as appropriate.
- 5. Provide to those facilities where the residents may be transferred any necessary information to assure continuity of care for the resident.
- 6. Coordinate/assist with the transfer of *continued on p. 2*

personal belongings of the resident.

Additionally, the facility administrator must:

- 1. Notify the Division of Health Licensing in writing as to the anticipated date of closure of the facility.
- 2. Notify the S.C. Board of Long Term Health Care Administrators in writing that he/she is no longer the administrator as of a given date.
- Notify the Division of Health Licensing in writing as to the location address where each resident was relocated
- 4. Notify the Division of Health Licensing in writing as to the storage location for resident health records for the 10 years following closure of a facility.
- 5. Return the last license issued by the S.C. Depart ment of Health and Environmental Control to the Division of Health Licensing.
- 6. Confirm the date of closure of the facility in writ ing to the Division of Health Licensing.

The S. C. Board of Long Term Health Care Administrators and the Division of Health Licensing of the S.C. Department of Health and Environmental Control work together to assure these responsibilities have been fulfilled. Community residential care facility administrators are advised to ensure they have completed these requirements when appropriate.

The Board has a new member from the Department of Health and Environmental Control, Leon Frishman, Deputy Commissioner of Health Regulation. UPDATE: Disciplinary Sanctions Issued by the Board of LTHCA

The Board voted to issue/accept the following disciplinary sanctions at the December 5, 2000, quarterly meeting:

- Administrator who failed to work at least 20 hours per week during normal business hours and submitted misleading information to the Board was put on a one-year probation and fined \$500.
- Administrator whose facility was in substantial noncompliance was put on probation for two years and required to obtain 12 additional CE hours.
- Administrator voluntarily surrendered license to practice in lieu of a hearing on formal charges of wrongdoing.

Register for Free OSHA Training

The South Carolina Department of Labor, Licensing and Regulation's Office Of OSHA Voluntary Programs Training Section provides free training programs on OSHA standards and various safety and health topics. These programs are available to employers and employees of both the public and private sector upon request and may occur on-site or during regional training. Regional training is held with educational or community centers in different cities around the state. Topics may include blood-borne pathogens, hazard communication, personal protective equipment and violence in the workplace, etc...

Information will be provided to help employers/employees maintain a safe and healthful workplace.

Six hours of continuing education is being approved for administrators. The OSHA training seminar will be a great opportunity to learn more about safety and health issues and get CE credits for the 2001-2002 license renewal.
