Carolyn was the administrator of an orthopedic clinic in Greenville, for 25 years. She left the orthopedic clinic to pursue a career in sports massage. After completing 800 hours of training in Virginia Beach, Va; she started her practice in Greenville in 1992. She currently has more than 1500 hours in training. In 1994, she wrote the legislation to license massage therapists in South Carolina. The bill was passed and signed by Governor David Beasley in 1996. Carolyn has been an activist in educating the public regarding the benefits of massage and received the National AMTA Activist Law and Legislative award in 1997. She currently serves on the South Carolina Massage Therapy/Bodywork Panel. #### **Renewal Process**

Once a person is issued an initial license, it will expire within one year from date of issue. (Example: You receive your license August 30, 2001. It will expire June 30, 2002.) It will need to be renewed during the month of June. Once it has been renewed, the license is valid for a period of two years.

## **Continuing Education and Audits**

Continuing education is required for all licensees except those with an **initial license**. If you have an initial license, the continuing education requirement is waived.

Twelve hours of continuing education are required in order to renew. When you receive a renewal notice and it is not your first renewal, you will have to sign an affidavit that you have completed the required 12 hours. The panel staff will audit a percentage of the affidavits. If selected, you will be required to provide proof that you obtained the 12 required hours. If you are unable to provide proof of 12 hours of CEU, your license may be sanctioned to include a civil penalty. Do not send your continuing education certificates to this office. Retain them in your records for future reference in case of an audit.

Continuing education can be attained from providers approved by one of the following associations: National Certification Board for Therapeutic Massage and Bodywork, American Massage Therapy Association or Associated Bodywork & Massage Professionals. Any of the massage schools, who are certified by the S.C. Commission on Higher Education, are approved as well. Individuals who have been approved by the S.C. Massage/Bodywork Therapy Panel are also eligible to provide continuing education. Renewal notices are sent to those who are eligible to renew. The renewal fee is \$200. Licenses renewed at that time are valid for a period of two years.

# **Disciplinary Information**

The South Carolina Department of Labor, Licensing and Regulation, is mandated by state law to investigate any and all complaints. A trained investigator will conduct a preliminary inquiry into all complaints to determine the validity of the allegations. Information will be presented to the Disciplinary Panel or designee to determine if a violation of the practice act has taken place. The complaint will be dismissed by the Disciplinary Panel if a violation is not found.

## If misconduct exists, two options are available to the respondent:

- 1. **CONSENT ORDER**: The respondent admits a violation and voluntarily cooperates with the Disciplinary Panel. The consent order may contain a sanction (private or public reprimand, probation, suspension or revocation) and/ or a civil penalty (maximum \$5,000) per violation.
- 2. **ADMINISTRATIVE HEARING**: If a consent order cannot be negotiated, the respondent has a right to a hearing. The hearing is held in Columbia in accordance with the South Carolina Administrative Procedures Act. The licensee is served with a complaint (30 days in advance) detailing the alleged violation and a hearing notice to include a hearing time and date. The licensees may represent themselves or obtain counsel for the hearing. The Disciplinary Panel considers evidence presented during the hearing and renders a decision as to the alleged violation.

The Disciplinary Panel produces a final order containing the dismissal notice or the sanction and civil penalty (if any) imposed by the Disciplinary Panel. All appeals are made to the South Carolina Administrative Law Judge, and thereafter, to the South Carolina Circuit Court. Appeals from the Circuit Court decisions are made to the South Carolina Supreme Court.

## **License Number Required for Advertising**

Please remember when you are advertising your services, whether it is in a telephone book, newspaper or business card, etc., it is required that your license number be included in that advertisement. Refer to 40-30-140 (B) of the S.C. Massage/Bodywork Therapy Statutes and Regulations. "A person licensed under this chapter shall display the license in a prominent and conspicuous place in the person's place of business and shall include the number of the license in an advertisement of massage/bodywork services appearing in a newspaper, airwave transmission, telephone directory, or other advertising medium."
