- Submit \$150 for one (1) year. (All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.)
- Applications must be postmarked on or before the date of your license expiration.
- After the date of your license expiration, licenses will lapse and practice is not allowed.
- If your Supervising Physician has changed, go here to download and submit a Supervising Physician form: https://eservice.llr.sc.gov/DocumentSubmission/
- Training Contract or Letter A letter from the institution stating that you have been recommended for a medical residency training program or a fellowship. The recommendation letter must be submitted directly to the board office by mail or email from the institution. A copy of the residency/fellowship contract submitted by the institution is also acceptable.
- If you have had a legal name change since your last application, please attach the legal documentation with this renewal form (marriage certificate, divorce decree, court documentation, etc.).
