APPEARANCES:

CLEMSON UNIVERISITY

Notice of Substantive Changes

Dr. John Whitcomb and Dr. Margaret Wetsel appeared before the Board representing Clemson University's Bachelor of Science in Nursing Program to discuss planned changes. Dr. Whitcomb stated that Clemson is expanding their undergraduate program and will transition to a new site of instruction. Dr. Whitcomb said that the curriculum used for the new site is the same as the curriculum is the same for the traditional students on the main campus. The Board inquired about the faculty size and Dr. Whitcomb stated that they had gradually increased their faculty by eight in preparation for the changes so that those faculty members could be familiar with the curriculum so that it would be seamless in terms of the teaching.

RECOMMENDATION FROM THE ADVISORY COMMITTEE ON NURSING EDUCATION

Position Statement on the Use of Simulation in Pre-Licensure Nursing Programs

Dr. Rachel Onello presented the Position Statement on the Use of Simulation in Pre-Licensure Nursing Programs that was developed by ACONE. Dr. Onello stated that she worked with Dr. Melanie Carson to revise the position statement based on the National Council of State Boards of Nursing's simulation study and the International Nursing Association clinical simulation learning standards of best practice. The position statement pulls from those standards that are international and widely accepted across the profession.
