2022-2024 MILITARY SERVICE LICENSE RENEWAL APPLICATION

The South Carolina Military Service Occupation, Education, and Credentialing Act exempts licensees on active duty military service from the continuing education and license fees during periods of service. Military service orders must be submitted with this application in order to notify the Commission of the claimed exemption and to renew your license. This renewal application must still be completed to renew a license.
