- Renew (Postmarked) on or before June 30, 2023, the renewal fee is \$220
- Renew (Postmarked) on July 1, 2023 – June 30, 2024, will be assessed a \$50 late fee for a total of \$270. You are not allowed to work after June 30th until a renewal has been processed.
- After June 30, 2024, a reinstatement application will need to be completed.
