2023-2025 SPECIALTY CONTRACTOR REGISTRATION RENEWAL APPLICATION

Renewal Instructions/Requirements:

- Renewal form, fee in the form of a check or money order (no cash) made payable to LLR SCRBC and any other applicable documentation are due by June 30, 2023. (All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.)
- Renew (Postmarked) on or before June 30, 2023, the renewal fee is \$100
- Renew (Postmarked) on July 1, 2023 June 30, 2024, will be assessed a \$20 late fee for a total of \$120. You are not allowed to work after June 30, 2023, until a renewal has been processed.
- After June 30, 2024, a reinstatement application will need to be completed.
- If you are changing a classification, you must provide a reference letter. No changes will be made without the reference letter being included. Reference letter(s) must be in your name, list the trade being requested, and include the contact information for the individual writing the letter. Classification changes may only be done during renewal. Once the registration has been renewed, your classifications may not be changed until next renewal. If you do not currently have the maximum three classifications, you may add a classification at any time.
