EXAMINATION WAIVER AGREEMENT

- 3. Licenses issued pursuant to this Agreement shall be issued only for equivalent and/or compatible classifications.
- 4. This Agreement applies only to the examination requirement, and all other licensure requirements of the Board and the Commission must be met before a license may be issued pursuant to this Agreement.
- 5. This Agreement shall become effective on October

 1, 1990 and may be terminated by the Board or the Commission at any time thereafter.
